

## PAVONIERE POOL RULES

1. The public will have to follow the opening and closing times of the facility. The schedule is accessible to the public at the entrance of the facility. The pool users will not be able to occupy the spaces reserved for the swim class and they will only have access to the spaces indicated by the lifeguards.
2. Pool's dimensions: 33m x 16m, depth of 1.30m to 2.20m and 16m x 18m, depth 1.10m.
3. The maximum number of persons present at the same time in the area intended for swimming and swimming activities is 400 people
4. The use of a swimming cap is mandatory to access the pool
5. The valid receipt given as an entrance ticket must be kept until you exit the facility and must be shown at the request of the staff. **The receipt must be valid, whoever does not have it will have to repurchase and/or may be immediately asked to leave the swimming facility.** The ticket entry can't be reimbursed.
6. It is mandatory to have a document of identification that can be requested by the staff. Those without it can be ask to leave.
7. There will be lifeguard's for assistance in the opening hours for the public.
8. Children under the age of 12 will not be able to enter the facility unless accompanied by an adult who must assume full responsibility for them. The staff has the right to **remove** the unaccompanied 12-year-old from the facility.
9. Users are advised to swim only three hours after the last meal, preferably light.
10. People suffering from contagious diseases or those with skin lesions and/or significant injuries will not be able to access the swimming facility. The user will only be able to enter the pool by showing a medical certificate stating that the illness or injuries are compatible with swimming in a public place.
11. It is forbidden for anyone in an altered physical state (drunkenness, drug abuse, etc) as well as anyone with an obvious precarious health conditions, to enter in the water. **Such as to eliminate any risk for the safety of the person.**
12. In the time reserved for the free swim, it is not recommended to introduce into the water dinghies, life jackets, masks and other educational tools. The use of a lifebuoy is reserved for the small pool with an adult's presence in the water.
13. In case of bad weather or rain the swimmers must leave the pool and the pool deck as soon as possible upon directions of the lifeguards.

14. It is forbidden to consume food or drinks (excluding water) in or around the swimming pool as well as in the changing rooms.
15. You are not allowed to dive, to run, play with balls, and/or distract customers in any other way.
16. Apnea diving is prohibited.
17. It is forbidden to run on the pool deck.
18. It is forbidden to introduce your own equipment such as: umbrellas, deckchairs, beds, chairs, and/or tables.
19. Smoking is prohibited on the pool deck.
20. For hygienic reasons, no pets are allowed in the pool.
21. The direction is not responsible for the objects and values brought into the swimming facility by the customers. The use of a locker is available.
22. It is mandatory to take a shower before going in the water.
23. The toilets are located in the changing rooms.
24. It's mandatory the sun bed for stay on the pool deck.
25. it is mandatory to access the pool deck only from **the special entrances**, after having passed through the foot-washing basin.
26. It is mandatory to wear :
  - a bathing suit in compliance with the rules of hygiene and public decency
  - suitable footwear (non-slip and reserved exclusively for walking on the pool deck and the annexed rooms
  - It is not allowed to circulate with outdoor shoes in the changing rooms and on the pool deck
27. It is mandatory to wear the entrance bracelet.
28. It is not possible to have glass objects on the pool deck: the use of glasses must be authorized by the lifeguard.
29. The first aid room (nurse) is on the first floor with an easy access from inside and outside of the facility.

30. The use of cameras and/or video cameras must be previously authorized by the pool staff.
31. **The facility and the equipment** supplied by the facility must be used with respect. Any damage, even if unintentional, must be reported to the pool's staff.
32. In-service personnel are authorized to intervene to ensure compliance with these regulations and to remove any offenders.
33. It's forbidden to introduce inside Le Pavoniere (green area, bar area, front office, pool deck, changing rooms, ecc.) scooters and bicycles ecc.
34. It's forbidden to introduce animales.
35. At the entrance to the facility there is a telephone set from which emergency assistance can be requested
36. In the condition of bad weather, swimming is prohibited.
